

## National SCRABBLE® Championship 2010 Vendor Agreement

I understand that I will be allowed to sell SCRABBLE®-related items at the National SCRABBLE® Championship at the Intercontinental Hotel, Dallas, TX August 7-11, 2010 pursuant to the following conditions:

Vendor space is available at the opposite end of the playing room from the player tables.

Vendors are responsible for handling the setup of their display and vending area and their sales or providing someone to handle their sales.

A vendor may use one 8-foot tournament-size table at no charge. There will be a \$100 charge for each additional table, with a limit of 5 extra tables per vendor, payable to NASPA, PO Box 12115, Dallas, TX 75225-0115 no later than July 1, 2010. No monies or requests will be taken after that date.

No vendor signage is allowed anywhere in the ballroom other than described below:

Vendor advertisements and signage are limited to the size of the front of the tables used by that vendor, not to exceed the height or width of the table. Any signage behind the table is subject to the same limitations. The top of any signage is not to be any higher than the level of the table top. What we are envisioning is that signage be from the top of the table to the floor. Nothing is allowed on the walls.

Free standing signage is allowed adjacent to your table(s). The cost to display this signage is \$100 for every 8' of width or portion thereof with that measurement beginning at the end of your table. Said signage may be no taller than 6' with a depth of no more than 30". In other words, you may substitute signage for an extra table, but the amount of space available, the cost for the space and the dimension restrictions are the same as an extra table except for the additional height allowance. Mary Rhoades or an appointed National SCRABBLE® Championship representative will determine your exact location within the playing area no earlier than August 6.

The Intercontinental Hotel, Chris Cree and Mary Rhoades are not responsible for merchandise left in the playing room at any time, either during sessions, or between the end of the afternoon session and the beginning of the morning session, and is left at the vendor's risk.

If any of the conditions of this vendor agreement are broken, the vendor will immediately lose the right to sell merchandise at the tournament and will be so informed by Chris Cree, Mary Rhoades or an appointed National SCRABBLE® Championship representative and will be directed to remove the merchandise at that time.

We reserve the right to terminate this agreement at any time for any reason that we feel would be detrimental to the experience for the players of the event.

There are no refunds.

This vendor agreement must be signed and returned to NASPA, PO Box 12115, Dallas, TX 75225-0115 no later than July 15, 2010.
