Neither the facility at which the 2023 Tournament is held, nor NASPA, nor any of their respective employees, agents, contractors or representatives shall be considered as "bailees" and they shall not be responsible or have liability in any way for any goods, merchandise or signage in the tournament area, the tournament facility or otherwise, at any time; all of which shall be placed, displayed and stored solely at the risk, responsibility and liability of Vendor. Vendor hereby releases and holds

\$100 for every 8 feet of width or portion thereof. Such adjacent signage shall be no taller than 6 feet, nor have a depth in excess

of 30 inches.

Vendor shall be permitted to display free standing signage immediately adjacent to its designated table(s), at a cost of

harmless NASPA, its employees, agents, contractors, representatives, and any other party claiming through or under them, from any liability arising in any way from Vendor's display and/or sale of goods at the 2023 Tournament.

- 5. If any of the terms, conditions or provisions of this agreement are violated by Vendor, then Vendor may be subject to the immediate loss of its right to display and sell merchandise at the 2023 Tournament and, in such event, Vendor will be directed to immediately remove its merchandise, tables and/or signage.
- 6. Vendor will comply with all sales tax and other laws that pertain to the sale of Vendor's goods, and shall report and pay taxes in all applicable jurisdictions, in accordance with relevant tax laws.
- 7. NASPA reserves the right to modify the layout or dimensions of the vendor or tournament area at any time prior to commencement of, or during, the 2023 Tournament, in its sole and absolute discretion.
